My Dear Secretary-General Ban Ki-moon and to whom it may concern:

Officially by the history of China, I am China's current succession emperor. This fact is known to the U.S. government, whether they acknowledge it or not. Sometimes, there is no justice for lesser nations and lesser nations need to resort to war and subterfuge in order to get their way and survive, especially against our nation's economic will and might. Terrorism is promoted by our nation, secretly and covertly, so that other nations will not get ahead and the United Nations, at times, is run at the will and at the behest of the U.S. government. Is this not so!

When will the illegal American President do the right thing and conform to his own nation's national election laws and conform his nation to international laws regarding his nation's criminal and illegal military actions abroad.
