Dear Secretary Duncan,

This is my 13th letter (approximately) sent to you since September 4, 2009. Why haven't you replied? I, also, sent to you letters that were addressed to both you and the President, dated June 1, 2010 and June 16, 2010, as well as many other letters; including confidential letters and matters, and affairs of state (private letters of my negotiation activities). Officially by China's history and by China's Han-Chinese court and court system, I am China's current emperor today, emperor-in-exile. This fact is known to your nation's intelligence as well as to your current President. Yet, somehow he refuses to reply to my letters. From the time he declared his candidacy for the Office of President, I have sent him over 160 letters; 76 plus letters in his capacity as President.

In the beginning, I wrote to him to advise him that I was President Bush's "unofficial" Iraq War negotiator. And that I was the person responsible for successfully securing Saddam's agreement to the Bush White House demand for his withdrawal from Kuwait. That I am very knowledgeable about this conflict and war, and that he should meet with me to get an outside view (outside of normal Washington DC views) on the matter. I received no reply from the President.

I received, to my knowledge and memory about six letters from the US Department of Education, which were standard form letters, generally sent to student-loan holders, which did not directly address pertinent questions that I had asked in past letters to you. These letters were addressed to, me, HIM Yao Sui coming from the Department of Education. And I have never heard from you in all of this time (September 4, 2009 to June 25, 2010).

I am officially Emperor of China and China's head of state in exile. I am covered under the Vienna Convention on Diplomatic Relations 1961 for all and any matters which your government may want to address. Being that I am such a very important person, a letter from you as well as from the President would be warranted. Have you spoken to the President about this?

I am the best person that your government could use to help end the Iraq War and all other subsequent wars stemming therefrom. Being a very loyal American, I am, again, the best person to bridge the gap between the United States of America and Asian nations, including China. Sometimes many of your nation's solutions to problems faced in the Middle East and Asia are dishonorable, yet situational and necessary (illegal). Some people would call this dishonest and corrupt politics, done for our nation's welfare and survival. If people high up in government factored into this equation an upright Hebrew family ruling Iraq and the same situation in China, US foreign policy and affairs would change and would certainly be different.

Instead of making war and illegally bombing Iraq with the possibility of the same in China, our government would seek to press these nations for dialog. Also, requesting that China intervene in the North Korea situation and help promote regional peace, so our troops would not have to be killed or go to war. The dynamics of war changes with complete information, rather than lies. Covert armies by night, as John F. Kennedy said and implied, would disappear and our world would be that much better. Terrorism would disappear from the face of our earth, as terrorism occurs due to our nation's intransigence and hidden desire to make war with other nations. War is bad, because many innocent people are killed, millions upon millions, and hundreds of thousand upon hundreds of thousands. Our nation initiates war as a defensive mechanism to protect our nation and way of life, yet the way in which we go about this, through covert means and subterfuge, is criminal at best and wrong.

President Obama is a good man, but inexperienced and a puppet of the Bush administration. Collecting a salary of \$5.5 million seems to weigh more heavily with him than true peace and justice. More heavily than doing his job as President and carrying out his oath to protect our nation!

I am not familiar with the laws and I would like some clarification unbiasedly on your government's part as to what rights and responsibilities I am to carry in my role as a US foreign affairs and international political negotiator and go-between, a man seeking peaceful relations to the many political crisis faced by your nation in both Asia and the Middle East.

I would, also, like to seek your nation's remedy to my abuse by federal agents and others, during and in connection with my schooling. These are things that were asked for in my previous letters, but never answered by you.

From my paternal ancestry I am a Hebrew and from my maternal ancestry I am a Mede. My family was conscripted into slavery in ancient times, by Nimrod, and absorbed into Nimrod's Hamite bands (which included the Chinese nation). So, my outlook on life and politics

follows my ancestry rather than nationality. I am, therefore, a man of God and a Christian in my approach to the political world. I believe in the goodness of man with great faith in God. When I am in my role as a nation-to-nation conflict negotiator, I maintain the same posture of God and honesty first, while looking for good, decent, and upright solutions to help resolve our world's political crisis.

Sometimes, it is our nation that is wrong rather than the other way around. And when we are wrong many innocent people are killed. My meeting with the President would bring these facts to light and would allow him to be able to set up an upright policy and agenda with regard to foreign relations with other nations.

What I have been asking and mentioning to you is that these loans be maintained by the US Department of Education, rather than by a non-government agency, which has no authority to dictate or oversee US foreign policy or matters of state with respect to my future income, career maintenance, and political status, when it comes to dealings with me and to even forgive debts. Standard replies from your Department of Education are not and have not been totally correct, but rather evasive. As your department's replies seem to misunderstand and misstate my words with regard to these loans.

I am a complete package of all of the above. And this matter should be one for the President to remedy in conjunction with the US Department of State and the US Department of Defense. And the terms, if any, should then be laid out by these people and be forwarded to your Department of Education for a final resolution. President Obama and others, therefore, need to speak with me!

You have a copy of all of my letters, even letters sent to you not mentioned above. It is my intention to have them attached herein by reference. Please let me know which letters you have in your possession so I will be able to better address any concerns which you may have about the entire matter.

I have been a victim of police beatings and beatings by thugs, falsely arrested and once left for dead. I have security concerns as people, who are known hoodlums as well as homeless people, have threatened my life (this has been documented, but not acted upon by an errant police department and errant FBI). My family, father and mother, while they were alive, were threatened by the police with death, if they interfered with my arrest (the police feeling that an old Chinese emperor would still have considerable influence with the general community and could undo their arrest). And my family's age old enemies, the Manchurian conquerors of China, are still active claimants to your family's throne in China. History has shown that they kill and murder without warning. Then, too, there are nutcases and kooks, as well as people in America, who say that they just don't like emperors, who could threaten and kill me. Some of these things have already happened, so it is very important to be quietly and officially recognized by your government, so as to be qualified to receive Secret Service protection and rights as a foreign dignitary under the Vienna Convention on Diplomatic Relations 1961. I have already encountered such problems and I do need the protection of the laws, both US and international. This protects me, my person and my good name.

I am in extreme poverty with very expensive and immediate dental, medical, and legal needs. Privately, may I say, I eat at church soup kitchens as I have no money and no paying job. This is an unsafe condition for a foreign head of state and a government negotiator. Someone who could end the Iraq War and bring peace to the South Korean conflict as well as to assist and to help set up a good and honorable, truthful and upright, agenda and foreign policy for the US government regarding Middle East and Asian political relations.

Why, for God sake, hasn't Obama written! And where is his birth certificate? I like President Obama, yet he wouldn't be facing these kinds of problems if he had acted much earlier.

I need legal recognition by your nation, so as to qualify for US Secret Service protection and so the police then will know better than to arrest me. I have not done things to merit arrest and yet I have been arrested and beaten many times maliciously! This would not occur with recognition (as mentioned above) and the weight of the US government behind me.

Younger cousin of the late Premier Zhou Enlai; younger cousin by marriage-ties to the late Chiang Kai-shek and the late Sun Yat-sen; 8th generation descendant of Chang Cheng-kung (Koxinga); 5th generation descendant of Lum Tse Hsu, Governor-General of Hunan and Hubei provinces, Imperial Commissioner in charge of banning opium; grandnephew of the late Henry P'u Yee Aisin-Gioro, last Emperor of China (Ch'ing Dynasty); great-grandson of Chow P'an Lung; China's current Emperor, head of state of China by virtue of title; and China's symbolic Son of Heaven.
