My Dearest President Obama,

I've written to you many times in the past and I have sent you over 200 letters. And, somehow, I haven't received a reply back in return. Truthfully, why? Who can oppose the American government, even if America is a criminal, murderous, and corrupt lawless nation? and affairs, not telling the real truth of American foreign affairs abroad?

We send spies into foreign nations to disrupt less developed nations and rise up rebellions against those nations who might not agree with us. Then, too, when a rebellion occurs (instigated by our nation's intelligence community) and oil is involved, we take issue with the governments of foreign nations, have them overthrown, and their leaders killed. People like Osama bin Laden is not a criminal as true justice would consider. He could be duly considered to be a tribal chief or political leader. In which case, having him assassinated would be considered to be both illegal and wrong. Why does your government, our government, do such things? And why do you go along with your government's criminal behaviors of regime change and assassination of foreign leaders? It is a wonder that God, the true god of creation, whose name is Jehovah, will allow such things to happen and allow the guilty to go unpunished! It is a wonder why wicked world governments can punish other governments and impose their own ways unrestrained! Where is dialog and negotiation? Has peace and uprightness gone out the door with God in your nation? Do you not believe in and do your Christian churches not believe in and desire diplomacy over murder, when diplomacy has been proven to work time over time!?

Our shooting missiles into another nation is highly criminal on our nation's part, an act of aggression and war on our nation's part, and a violation of U.N. and international laws. Every nation has the inherent right to sovereignty. People are obligated to obey the laws of their land. It is wrong for any nation to stir up rebellion in another nation, such as we seem to always do in other nations and then later act innocent as if we do not really know what is going on and blame that nation's government leaders as being oppressive, when they in fact are not and have never been.

In 1990-91, I secured Saddam's agreement to the Bush White House demands for his withdrawal and I let your government know this in a timely fashion. Yet, they reneged and continued to broadcast on national television that Saddam had refused to withdraw. Your nation sends spies into other nations and they rise up rebellions. Your nation's press often lies about international conflicts and does not always tell your people and this world's people the truth of various conflicts and wars.

There was a time in our nation's history, when we were the good guys. Fighting evil and bringing goodness and truth to the oppressed throughout the world. When did we stop doing this and when did we become the aggressors?

In 1990, Saddam marched his army up to the border of Kuwait, because Kuwait had manipulated the price of oil in opposition to and contrary to rules of OPEC. I am a good man hoping to bring God to China and wishing that China will humble herself to the true god of the Bible, rather than to ignore and dun him. Please, I do wish that I will have the love of your people and your nation's blessing for my true Christian mission to bring God and the Holy Scriptures to China's 1.4 billion people.

Three generations in my family have loyally worked at Pearl Harbor Naval Shipyard. My maternal grandfather was a shipwright, my father was a radio operator, and I worked there as a military housing carpenter.

The United States of America has been criminal in its actions against Iraq and the regime of Saddam Hussein, the United States of America has been criminal in its conduct against the nations of Libya, Egypt, and Pakistan and criminal towards legitimate governing regimes around the world; assassinating or setting up the assassinations of foreign leaders secretly and covertly; and being responsible for the deaths of President John F. Kennedy, Robert F. Kennedy, Martin Luther King, Jr. Responsible for allowing Japan's invasion of Pearl Harbor and responsible for 9-11.

Kuwait conspired with the United States of America, back prior to 1990, lowering the price of oil to damage Iraq's war-torn economy and when Iraq marched its army into Kuwait as a policing action, we deemed Iraq's policing action as an illegal and murderous act of war and outright hostility that our nation had to correct. We repeat the same pattern done to all of the other nations around the world. To China, almost, to Iraq, Syria, Egypt, Libya, and Pakistan. Doing so is blackmail and criminal conduct against legitimate nations who do not agree with us all of the time. We lie and murder people and nations without international inspection, observers, and international debates and observations.

A new President comes along and he, too, you Mr. Obama, knowingly repeats the same illegal and criminal actions! When is our nation going to confess its criminal wrongdoing, repent, and compensate the people and nations which we have wronged?

NOTE:

This letter was re-mailed to President Obama, on May 6, 2011, as a reminder to him that (1) I am China's official succession emperor, head of state of China (presently, a communist nation); (2) that I am poor, unemployed, homeless, and disabled, and living in the United States of America (formerly as a street person for a few days); (3) that I and my family (paternal and maternal) have always been loyal Americans (1871 to present); (4) that due to my poverty, I am requesting and hoping that this nation will be able to provide for my many needs (until such a time, when I can get up on my own or until such time when the nation of China might come to a realization as to who I am and will provide for my needs), id est: medical, housing, food, transportation, and security protection. And do such in view of and conforming to the Vienna Convention on Diplomatic Relations 1961, other rules, laws, and regulations, which protects my dignity, name and person, which guarantees my personal security and safety, and doing the same for my family and other people who are part of my contingent. (5) In 1990-91, I was the negotiator between President George H.W. Bush and President Saddam Hussein Abd al-Majid al-Tikriti of Iraq. Saddam agreed to the withdrawal, yet your nation/our nation illegally and criminally went to war, though this man had agreed to terms demanded by our nation! (6) And that his nation's actions in Iraq, Libya, Afghanistan, and Pakistan are wrong and criminal by U.S. laws and by international laws and standards.

Now you shoot missiles into Libya and send troops into Pakistan in an effort to kill one man, a witness who could testify against United States of America for its international wrongdoings and murders. That he was an innocent by-stander caught up in emotion matters and made a number of statements against the U.S. government, but was not and has never been responsible for criminal activities which your nation, our nation, has attributed to him.

Are you not a Christian and does your nation not believe in and support the Christian god (Jehovah)! Do you not follow the law and is your nation a nation of evil doers who do not follow or believe in the "rule of law"? Is your nation a lawless nation of murderers and thieves, hiding behind the administration of the law while acting crookedly and contrary to written and ethical laws.

I would most certainly like to bring this matter to the International Court of Justice, the United Nations, U.S. Congress, and present the same to NATO and to the entire world in an effort to put a stop to your nation's criminal and murderous actions.

I would most certainly like to bring this matter before every nation on the surface of this earth, because there is a god and goodness is supposed to exist in this land and upon this earth. Man cannot be lawless, nor should he be a scheming evil doer. If

corruption exists, many nations are willing to say behind closed doors, it is with your nation with your government and people that are the true causes of such things throughout the world.

You judge people and nations, and execute judgment by physical force by use of advanced weapons, weapons of mass destruction. And do not publish the truth for the entire world to see. Decisions are made behind closed doors and lies are spread as to what you are doing and as to why you are going to war. Rather than to capture Osama, as an example, you choose to execute him. Wouldn't it be fair to try the man in a just and lawful court, rather than to condemn a man without trial?

Are you a law unto yourselves? Will you allow your nation to go on trial for all of the crimes that your nation has committed around the world and allow for a free press (free world press) even to tell my story, this story, worldwide?
