Dear above-named individuals,

I am an American citizen of Chinese ancestry. My family migrated to the United States of America, Hawaii, in 1871 from China. My older second-cousin is China's late Premier Zhou Enlai. I have been back home to China, once, two years before the Tiananmen Square incident. And I am writing this letter hoping to gain your approval and support for my return to China. As all of you do or should know, my family is China's royal or imperial family and we have lived in the United States of America, Hawaii, since 1871. In 1990-91, I was the negotiator who secured Iraq's President Saddam Hussein's agreement to his withdrawal from Kuwait. This matter was ignored by the press and by the Bush administration in an effort to take our nation, the United States of America, to war. I am currently poor (without any money), unemployed, disabled (two bad knees and a bad back), and homeless. I finished four years of college and worked as a business consultant and political negotiator under the name of and with the business firm of Lester D.K. Chow and Associates.

I am more than qualified to receive your full attention and an immediate and full reply to these letters. You will find this letter along with others posted at <http://himyaosui.wordpress.com>.

I am asking for official recognition from the U.S. government, so as to receive Secret Service protection and sponsorship from the business community, when President Obama and/or the U.S. government recognizes my standing.

I am asking for funds to return to China as I have none presently.

And I am asking for China's permission to return home without reprisals against me and my family.

Money is needed for my return, transportation for myself and for everyone in my family as well as the cost of informing all of my family members as to our status in this nation. Secret Service protection on an official basis is needed to insure that everything goes smoothly and that we are guaranteed the protection of both governments legally and officially.

I believe in America and I believe in China. I hope that both nations will not turn me away and will not let me down. I am a political moderate, who believes in God and is a Christian. I seek to work with both nations, rather than to work against their interest.

If you can see your way in helping me, a truly good man, please let me know. If you have any questions, please do not hesitate to write.

I am a truly good man and benevolent soul. A man who usually has the best interest of others at heart.

Younger cousin of the late Premier Zhou Enlai; younger cousin by marriage-ties to the late Chiang Kai-shek and the late Sun Yat-sen; 8th generation descendant of Chang Cheng-kung (Koxinga); 5th generation descendant of Lum Tse Hsu, Governor-General of Hunan and Hubei provinces, Imperial Commissioner in charge of banning opium; grandnephew of the late Henry P'u Yee Aisin-Gioro, last Emperor of China (Ch'ing Dynasty); great-grandson of Chow P'an Lung; China's current Emperor, head of state of China by virtue of title; and China's symbolic Son of Heaven.
