Dear APEC 2011 Hawaii Host Committee,

I have no idea if I will be invited to the APEC CEO Summit 2011, which will be held in Honolulu, Hawaii on November 10-12, 2011. I am embarrassed to say, but I am poor, unemployed, homeless, and disabled. In 1990-91, I negotiated (Lester D.K. Chow and Associates) and successfully secured Saddam's agreement to the Bush White House demands for his withdrawal from Kuwait. Saddam agreed and the U.S. reneged. This was never published in the news media and I was responsible for securing Saddam agreement, which I had successfully done.

My first letter to APEC was dated and sent May 15, 2011. My second letter to APEC requesting admission to your APEC summit was sent and was dated July 15, 2011, yet I have not received a reply back in return. Many people in the U.S. Department of State know me, because my family, which comprises of 80 percent of Hawaii's local Chinese community, fled China, when it was run by China's Manchurian-led dynasty government (C'hing or Qing Dynasty) in 1871 and came here in secret, in hiding, for our safety from China's then-Manchurian dynasty government.

My resume and information about me appears online at my websites above as well as in intelligence information and reports gathered by the U.S. government from the time of my grandfather's arrival to Hawaii in 1871 to date. In 1990-91,

I was the government negotiator between U.S. President George H.W. Bush and Iraq's President Saddam Hussein. I was able to secure Saddam's agreement and he was willing to withdraw and fully comply with demands made by the Bush administration with some limited conditions.

Again may I say, I am poor, homeless, unemployed, and disabled. Your immediate help will be greatly appreciated. Please immediately get in touch with me as I have basic needs (physical-mobility) as well as urgent and pressing security needs as a foreign head of state and nation-to-nation conflict negotiator. How much does the safety and security of a foreign head of state living in your nation mean to APEC or even to President Obama and Secretary Clinton? I seek good relations and to build friendships.
