Dear President Obama and Secretary Clinton,

This is my 116th official letter and over 220 sent to date without a reply back from either of you. Quite irresponsible, don't you think? The reason I am writing is to secure official recognition for myself, as China's emperor and head of state in exile, because of dangers that I face in your nation from sources within and from the outside as well as writing due to my poverty and disability, both, which needs your attention and remedy.

I am poor (without any money), unemployed, homeless, and disabled. May I remind you that I am a foreign head of state. My family fled China to come to this nation from China in 1871, due to Manchurian persecution and certain death. My grandfather came here as a boy brought by his family and older sister, who acted in the place of his mother. My father and I were born here, yet an imperial succession is passed down from father to son and even the royal family of Afghanistan faced the same problems, as we, China's royal or Imperial family, do, where three generations have lived abroad. His in Rome and my family in Hawaii USA. Being in exile does not negate our royal or Imperial heritage and claims.

I am seeking official recognition and Secret Service protection for myself and for my family and clan. I am in need of money as I have none and I am hoping that your government might be able to, with the greatest degree of dignity, provide for our/my needs, as China's emperor and as a loyal U.S. ally, while we are in your country. I ask for nothing more. Because my family fled from China with nothing are we entitled to receive your nation's goodwill?

I would be very happy to meet with you to discuss foreign policy and world events. I am not here to supplant China and I am not a competitor to the Chinese government. I am, by my heritage, a part of China no matter who is ruling the country, democratic or communist regimes.

If you deny this request (done over 220 times), I would think that you should have sent a decent and dignified reply stating such and the reasons for the denial. Isn't the head of state of any country entitled to such? It is wrong to play political games as whatever you do will become manifest eventually!

It's good to have honor and dignity, rather than to make bad and selfish political decisions and to be later caught in your mire.

I have a bad back from my years working as a carpenter (36 years ago) and I am and have been unemployed, consequently, ever since. Within the past year, my legs gave way, possibly due, again, to my employment as a carpenter and old age. I, now, walk with the aid of leg braces and crutches and am permanently disabled (medically). I hope that my condition will get better and that I can represent my family and nation to the entire world in good health and in good physical condition. The United States of America is known not only for her abundance, but for her top medical facilities and doctors. Might I be availed of this, too.

I am a part of China's communist government as China's emperor. I am not a competitor to China's government.

I hope to attend the APEC Summit and I hope to meet you and Secretary Clinton there. I am China's current succession emperor in exile. My family fled China during the Manchurian conquest of China in 1871, so we are not necessarily known to or directly connected to China's current communist regime. We, I and my family, are loyal Americans seeking to return home, but are in need of the necessities of life (as stated above) for our exiled stay, from the Ch'ing Dynasty government in 1871, while we are in your country.

I hope that I am not denied an invitation to the APEC Summit, based on political reasons or by the urgings of the Obama administration.

I sincerely hope to hear from you, both, personally, rather than to receive a letter from an underling as I am a very important person by my family's heritage, loyalty to this country, and future political support that I should be able to provide to the US government and nation, as China's head of state and emperor and as a political negotiator in dealings and relations with and among other foreign nations not only mainland China.

I am a good man and honorable Christian.

loyally worked at Pearl Harbor Naval
Shipyard. My maternal grandfather was
a shipwright, my father was a radio
operator, and I worked there as a
military housing carpenter.
