Dear President Obama and Secretary Clinton,

One, I would like to politely remind you (both of you) that I am a very important person, Emperor of China and head of state in exile, and that I negotiated a settlement between Saddam Hussein and your government in 1990-1991 ending the Gulf Crisis and possible war. (1) That Saddam had agreed to your government's demands for his withdrawal from Kuwait and it was your government that had reneged and not Saddam! (2) That peace was possible without your government having to resort to war. It always has been this way since 1990, due to the accord that I had secured from Iraq's government via Saddam Hussein. (3) That your government and your nation's press, somehow, has censored this story and has shut me up and relegated me to the status of a non-person. When will the real truth of the Iraq War and other international crisis ever surface?

Two, I do believe in democracy and freedoms practiced on a fair basis. Something, which I do not see in your country at this time. Why is this so? Would you like to explain this to me in person? Are you afraid of doing this for fear of your being indicted?

Three, I wrote you (Obama, Obama and Clinton) over two hundred and fifty letters. One hundred and twenty of these letters are formal letters addressed to the President and Secretary of State. Most of these letters echoed the same theme. 1. Secret Service protection for China's emperor and head of state in exile as well as the same for his family (as required by law, precedence, and circumstance). 2. I am a foreign head of state in your nation. I am, officially, by China's history and Han-Chinese imperial succession, emperor of the nation of China in exile. If I am not able to adequately provide for my needs, will your loving and benevolent nation provide for someone very important, an international VIP, who has your best interest at heart?

Exactly how important is my health to your nation and for my return home back to China? I had said many times publicly and on paper that I want to return home to China with the love of the American people and government. No better gift could America give China, then a truly upright and healthy emperor and head of state. A symbol of China's past and a leader of China's future to come!

I am in dire straits and in need of money for medical attention (vision, dental, legs, knees, and back), food, shelter, and clothing, etc. I have asthma, also, and I am in need of very expensive medical treatments for things which I can not pay for at this time, very expensive treatments for my vision, dental work, broken back, knees, and legs.

My needs are in the immediate and my condition is and will get worst and unrepairable, if not treated immediately!

Just how long does it take for the U.S. President to get back to China's Emperor-in-exile (a man who believes in American democracy and freedoms) with an answer to if he could be treated immediately or is to receive help in this nation?
