Dear President Obama and Secretary Clinton,

Once again may I state, officially by China's history and Han-Chinese imperial succession I am China's emperor and head-of-state-in-exile. (1) That my family fled China for our safety and very lives, from Manchurian persecution and certain death, and migrated, in secret, to Hawaii with other family members going to various parts of the United States of America and throughout the world. (2) That I and my family are entitled to the protections afforded to us by U.S. and international laws; and protections as given by the Vienna Convention on Diplomatic Relations 1961, other such and applicable rules, laws, treaties, conventions, and agreements (verbal and written). (3) That I have formally requested this from the United States of America's government and from President Obama, since 2009 (informally since 1990-91). And the U.S. government, President Obama, has not responded or replied to my official requests and many letters for official recognition and Secret Service protection for me and for members of my family and entourage.

The Vienna Convention on Diplomatic Relations 1961 (which I am qualified to be protected under) not only protects my person and name from abuse, slander, and death, but insures that my person and good name is afforded, rights and dignities, as applied to political persons of high political standing.

While this nation affords people the freedom of speech, one can not say "Kill President Obama!" or "President Obama is a stupid ass and murderer!" as people of high political standing are afforded many protections not given to other citizens. And such a person is entitled to political dignity free from slander and abuse.

In 1990-91, I secured Saddam's agreement to his withdrawal from Kuwait and thereby ended the Gulf Crisis. And I believe it was U.S. Secretary of State James A. Would a man such as yourself chose to lie, commit crimes of international treason, and murder thousands and hundreds of thousands of innocent souls (foreigners, people who are not of American citizenship and blood)? Why does the press, international press, not publish the truth of these incidents. Is the U.S. government too strong and can not be exposed/held accountable for their lies and international crimes/intentional murders?

How is it that we are one nation, indivisible, under God? With liberty and justice for all?

I am more than willing to appear on national television/international broadcast with you on these issues and more. You have a lot to answer for as well as your qualification to be President. It is widely known that you were born in Kenya and that your grandmother had secured a Hawaii birth certificate for her daughter and for her then-recently born grandson. Why hasn't the truth prevailed? This the kind of pattern that has prevailed in your life and administration isn't it? Don't Americans really and truthfully care?

The truth is that we are a nation of murders and thieves and that we lie and cover up the truth, when we need to for our own selfish and criminal desires and ends. Is this not so? What our nation has done, you, yourself, have, also, done!
