Message:

All of you do know me, if not by my many letters to you, and those who have been in Congress back in the 1990s and thereafter have received many letters from me to in my efforts to negotiate a settlement between our nation and the nation of Iraq. People within our nation's intelligence as well as many in Congress should be able to testify on my behalf as to what I did in 1990-91 and testify with respect to my identity as being China's official Han-Chinese succession emperor and head of state in exile. Saddam agreed to the Bush White House demands for his withdrawal making this war doubly illegal, unwarranted, and unnecessary. Yet, due to our nation's intransigence, we marched our armies into both Kuwait and Iraq and killed two million Iraqis needlessly.

My family fled China in 1871 to escape Manchurian persecution and certain death. I sent letters to President George H.W. Bush, President William Jefferson Clinton, and President George W. Bush requesting US Secret Service protection and protections as guaranteed under the Vienna Convention on Diplomatic Relations 1961 and never got a reply back in return. My student loans were put on hold as during this time, I was molested by agents of the federal government and the police. Three administrations did not make a serious attempt to collect these debts, until President Obama. Who was born in Kenya and held dual citizenship as a citizen of Indonesia, adopted by his step-father, and was a subject of Great Britain through his biological father. No man on the surface of this earth is or has been more lawless.

With Congress in a quandary over Iraq, the war escalates into Afghanistan and Pakistan. Our troops go into these countries (illegally and needlessly), bomb and kill people we believe to be, but not necessarily are, terrorist as well as civilians with impunity. Yet, the basis of the insurgency is due to our nation's illegal war in Iraq, which killed two million innocent Iraqis. Our troops are illegally stationed in these countries and our war in Iraq, as I continued to say with Obama not listening, is that this war and accompanying wars are illegal and should cease immediately! We, the United States of America, are certainly a murderous and criminal nation!

Letters by me were sent to the then-current UN Secretary General as well as to the then-current Pope, to many heads of state and prime ministers of many nations. And letters were, also, sent to many ambassadors of other nations. I sent out position papers to the two largest newspapers in 150 nations around the world on the matter as I objected to this illegal war against the nation of Iraq!

So, when will you end this illegal war or will you, your nation, under an illegal President, continue to kill and murder people? Will your nation ever publish the truth of this illegal and murderous war?

When is your nation going to grant me immunity from arrest and prosecution? I am a foreign diplomat and head of state of China, whose family went into exile in 1871 from our Manchurian captors to come to this nation for our safety and protection. Are you truly a lawless nation and a murderous one too!

Would your nation rewrite history and change the true facts of the above circumstances, justifying an illegal war and falsifying Obama's birth certificate?

Would you brand Saddam a criminal justifying your illegal incursions into Iraq (via CIA spies like Ahmed Chalabe) though the people of our nation by now fully know the truth and that this swindler, above-named, was born in the nation of Kenya and legally is a citizen of Indonesia through his father (step-father).

Is your nation going to end this war and the killings that you are now and in the past have been doing? Are you going to make a public admission and fully compensate the nation of Iraq, as well as other nations and people, for your illegal acts?

What is in the works, also, too, is a very upright and Christian China with me as China's next President (if you want to help and promote good things in our world). This man believes in democracy and western freedoms. Don't you want to see good relations in the world, peace, and prosperity for your nation honestly earned?

Will your nation come to terms with my being abuse and compensation, which is in the hundreds of millions of dollars of range as opposed to my \$17,000 student loans (plus interest) which I did not pay due to not having a job for all of these years. Mostly due to the political situation that I am in with respect to opposing your government and war as an honest and honorable US citizen. As another investigator said, the debt that you owe me is far greater than the amount of my debt to you. Would you consider forgiving this debt and paying me the difference in negotiation fees for my work and payment for being abused/molested in your nation and by and on account of government employees?

Will your nation ever admit your sins and correct them (as John F. Kennedy so honorably said)? Allowing people to go on with their lives and with some measure of dignity. Do people in high up in your government seek the deaths of upright citizens and government wrongdoing whistle-blowers?

Your nation needs to clean up its act! My reference is, also, to the series of murders during the time of John F. Kennedy's presidency and thereafter, our nation's attack on the World Trade Towers (9-11), and the illegal Iraq War, which spills over into Afghanistan and aPakistan. This is a war of our nation's making. A war which should immediately cease. A wrongful and criminal war on our nation's part. How say the illegal president, who was born in Kenya, and his chief advisors?
