Dear President Kim Jong-il,

Officially by China's history, I am China's current Han-Chinese emperor. Emperor in exile. My family fled China during the Manchurian Ch'ing Dynasty rule of China to come to America for our own safekeeping. We have been here in America (California and Hawaii) for the past 130 years. My grandfather was born in China. My father was born in America as was I. My family's succession is official as it comes from China's official court system, which went into hiding in 1644 to escape Manchurian persecution and certain death. All Chinese have a one syllable, one character surname. Manchurians are known by the surname of Aisin-Gioro, a four character surname. China having come out of foreign rule, by Mongolians, didn't want to be ruled by foreigners again, so a decision was made by court to continue China's official succession in secret and to restore Chinese rule to China. My family of 300 to 600 people live in Hawaii USA. We are the same size as the royal family of Kuwait and, like the king of Afghanistan, we have lived abroad for three generations.

I am a good man. A righteous man. A man of peace and a wise man, a Christian (Methodist). I am very loyal to the very high ideals of democracy and loyal to the United States of America, my adopted homeland. I finished four years of college and I am a partner in the political and management consulting firm of Lester D.K. Chow and Associates currently an inactive company. My firm in 1990, successfully secured Iraq's president's agreement to the Bush White House demand for his withdrawal from Kuwait and the war should have ended there.

I hate political corruption of all kinds. Lies, dirty political fighting, and gamesmanship. I am a man of god. The Christian god, whose name is Jehovah, whom all Christians worship. God of Shem, god of Abraham, Isaac, and Jacob. I believe that diplomacy should be conducted honestly and with an eye befitting of statesmanship. Anything less just will not suffice.

I am willing, like all Bible patriarchs, to go up against any world power and stand firmly with the true god Jehovah in all of my international dealings. That is why, sometimes, nations hate me, because I am honest and upright and not willing to compromise, lie, and play dirty games for their advantage, material gains, and specific sake. Cheating and lying is the way in which they achieve their objectives, done for material gains or for another bowl of rice to eat. For a Western nation to do such a thing is despicable and unthinkable. When you have every advantage in life and are the world's most prosperous nation, why would you want to cheat poorer, less fortunate, and less developed nations?

So, I am writing to you and to the entire world, through and by this letter, to let everyone and every nation know that truth and fairness, justice and mercy, should be the true order of the day. I am willing to act as a go-between in this conflict for the United States of America or for North Korea. I can not stand by while stupid nations kill themselves and create an unsafe condition possibly leading to a world war.

I openly admit that the United States of America is a good nation overall and a good nation by the written and public principles that she espouses. But, her government administration is sometimes crooked and corrupt. And the United States has in the past committed criminal acts of mass murder. Falsely accusing the nation of Iraq of having weapons of mass destruction and getting many nations from the UN (United Nations) to support her illegal war. When it was shown that Iraq did not have WMD, the United States still continued to kill masses of Iraq's people without apologizing for this illegal war. Two million innocent Iraqis were killed in total from 1991 to 2010. And war still continues until this very day!

So, due to things like this, I want to insure that true justice in the world is had and if North Korea was at fault that North Korea compensates South Korea, rather than to see nations at war. If South Korea staged this incident with the quiet and unspoken help of the United States of America, their wrongdoing should be exposed to the entire world and such behaviors made to cease!

That when government makes mistakes, it should be open to the public and even to the press. Allowing people to point out their (government's) mistakes and to correct them. A reference is hereby made to the late John F. Kennedy's words.

So, I am asking not only North Korea, in and by this letter, but I am, also, asking the United States of America, if they would either hire me or allow me to look into this matter so that it might be resolved peacefully. I am an impartial soul and a longtime government wrongdoing whistleblower, who almost lost his life many times due to the work that I have undertaken.

Too often Hillary is gun happy, very aggressive, and like a mother doing things to protect her nation, at any and all cost, including mistakenly going to war and falsely accusing other nations of some grave crime without having conclusive proof and without a fair and balanced investigation. This is how our nation got involved in an illegal Iraq War, which murdered two million innocent Iraqi lives. I was the go-between in this war and so I should know. I hope to have your word and answer by courier, rather than solely by letter. In this manner, you will be assured that your answer to my letter was received by me and I will know that your answer was from you.

In God's name, may this letter be respected by all concerned. A reply is hoped for from all parties named above and below within reasonable time limits. I would truly like to hear from everyone. One to two weeks, perhaps. The sooner, the better.
