Subject: CAN AND SHOULD AN ILLEGALLY PRESIDENT GOVERN THIS NATION HONORABLY AND DO ALL OF THE RIGHT THINGS?

Dear Mr. President,

ONE:

Let's play fantasy. Say, some man for all of his life did not have American citizenship. This man in order to function in American society without an American ID or legal birth certificate would have to keep a low profile and be beneath the radar. Say, he was born in Kenya when his mother went there to threaten her common-law husband and his family to support her unborn child. Say, they refused and this woman tried to get back on a plane to Hawaii and the airline refused to allow this woman to board the plane, due to her near term pregnancy. Say, her child was born in Kenya, Mombasa Hospital. Is this child an American citizen?

Through his father, he holds Kenyan and British citizenship and he is an alien in our nation. Let's say that this man's mother marries a man who holds Indonesian citizenship and the woman and her child go to Indonesia to settle in the new country of her husband's residence. And the child is enrolled in school as a Muslim and as a citizen of Indonesia. Question: Is this child a citizen of Indonesia?

Let's say that this man in his 20s applies for an Indonesian passport, based on his school records and Indonesian citizenship. Let's say that the Indonesian government grants this man's request. He uses his Indonesian citizenship and passport to travel to Pakistan to aid Muslim political causes with his friends. Question: Did this man violate any U.S. laws and is this man a U.S. citizen?

Say the same man ran for political office. Running and being elected as a U.S. Senator from Illinois. Can this man legally do this? Suppose he had fraudulent birth records and Hawaii's government officials went along with this fraud and hoax. Can these people now be indicted for violations of U.S. laws and held responsible for crimes of high treason?

Suppose this man, without having much experience, ran for the Presidency and his campaign people knew all about his past and tried to cover up his past. Suppose this man was elected as President and now had U.S. government officials, also, responsible for a massive government cover up of the truth. **If these things were true, tell me, what would you think of such a man?** Should this man at this point be facing jail time and a very stiff sentence?

TWO:

A very good and honorable man comes from China. While in Hawaii, he earns the respect of the community. His grandson, heir to the throne, is beaten and abused by the police. The man and his son dies and they pass their mandate/succession to the grandson. The grandson finishes four years of college as a business major and history minor and he wants to go back to China to rule. Feeling that he is an upright American, someone who believes in freedoms and democracy, someone who is a true Christian, who wants to, under the prevailing circumstances, Christianize the nation of China or in the very least promote open and good government in China and lead a true Christian mission for people to be able to have the freedom to worship. All of this done with the consent of China's people and government and without bringing about revolution and bloodshed. Question one: Is this a good man whom our government should support and protect? Question two: If he ask for official recognition, which he is entitled to under the Vienna Convention on Diplomatic Relations, can the President make a judicious distinction, a poor judicious-distinction, a judgment call, rather than to follow the letter of the law. In other words, if the President does not like some can the President deny this person of his rights? After all we are a lawless nation of men and not a nation of laws. Is this not true?

This man and his son are now dead and this man's grandson faces death at the hands of his political enemies as well as direct threats from the police, hoodlums, and from anyone else hating this very good and honorable man. And hating who he is and hating what he wants to accomplish. Is this kind of behavior typical of Americans? Is this kind of behavior something that our nation can be proud of? Because this man is head of state of a foreign nation as its emperor in exile, should the American President follow the written laws or can the judiciously make his own decisions apart from the law?

If our current President was born in Kenya and was a citizen of Indonesia, can he make his own laws that citizenship laws are unfair and discriminatory? And not obey our laws as written? Can this man get away with his crimes? Will our nation allow it?

China's current emperor is facing many problems and an adversarial situation, where people don't like him and consider him to be a threat to their stability.

If the President grants this man recognition, which he is entitled to by law and, also, entitled to under the Vienna Convention on Diplomatic Relations 1961, then people who oppose this man will accept the law as written and this man's problems will end. No one likes a fraud and though this man has sufficient documentation, his claims are being denied by citizens who are seeking to abuse him. People in America, sometimes, tend to be more emotional than rational.

Since the weight of evidence tends to be with this man from and before the time of his family's coming to America, known to many government agents and agencies, so shouldn't our current President recognize this man and render Secret Service protection (openly and legally, so that there is a degree of accountability) and the services of the U.S. Attorney to protect this man, based on U.S. laws and based on the terms of the Vienna Convention?

THREE:

If the grandson, after his inauguration or enthronement as emperor-in-exile, secured Saddam's agreement to the Bush White House demands for his withdrawal from Kuwait, and for that and many other reasons the war with Iraq and corresponding wars in Afghanistan and Pakistan are all illegal, should our current President ignore legality and continue an illegal war and murder people? Or do we continue killing and murdering people trying to protect and defend their rights and homelands from American aggression and illegal change of government regime?

I still have my student loan obligations unpaid and outstanding and your Department of Education has refused to act honorably and had been trying to, in the past, dun my good name and eventually expose my personal identity to the entire world, in protection of an illegal President, so I would not be able to harm you. Efforts to write to you and get a response from you have fallen on deaf ears. If the nation of China does something threatening or illegal, you should be speaking to me. I am not a communist, yet I am China's official succession emperor in exile and head of state thereby. As a loyal American, I do love this nation and I am not an enemy to China. You can promote peace by working with China's government for my return and you can be doing many good things in the promotion of good Asian relations, rather than your administration seeking unnecessary aggression and war with Asian nations. You need better advisors. People (Washington D.C. political advisors) act as you want them to act. They do this in an effort to keep their jobs. It shows that you do not know what you are doing as President and that you do not know what you are doing with respect to foreign relations and affairs.

FIVE:

We are a Christian nation. China is not. 80 percent of the people of the United States of America profess a belief in Christ and are called Christians. Over 80 percent of all of the people in China are atheist. In my eyes, it is a very shameful thing for the U.S. government to promote homosexuality. In ancient times, in God's lands, homosexuals were stoned to death by God's specific orders. Christians are supposed to believe in God, the father, and in his son, the Christ. And in the Christian belief that homosexuality is wrong and that homosexual practices are an abomination to god. That true Christian churches are not supposed to have homosexual pastors or homosexual heads. Neither are women to take the lead in the Christian church over men. I fully believe in this nation and God. And I am hoping that you will allow me to bring about good changes for China as China's honored and esteemed emperor and next president. It is wrong, very wrong to promote or say that homosexual conduct is permissible as homosexuality and sexual permissiveness works against the good order of society and the military. I am amazed and flabbergasted that our military's Chief of Staff can come out and condone open homosexual conduct. Especially in the military, where most of its members are between the ages of 18 to 22.

The "Don't Ask, Don't Tell" policy is a good one. It protects the honor and moral fiber of our nation's military and it allows gays to serve as long as they do not openly exhibit homosexual conduct.

Sometime, last year, I was fondled by a gay serviceman, who had a long record of service in the military. I was fondled in church of all places, on base as a guest of the base Chaplain. I say that the U.S. military should keep the "Don't Ask, Don't Tell" policy. It not only protects the morals of the base and base families, but serves to protect guest too!

If you still want, a chat with me would help (set your administration and foreign or Asian and Middle Eastern affairs in order). I would welcome such a chat. And with respect to my student loans, I will be writing to Secretary Duncan and I hope that he will be writing back to me. It is the responsible things to do. I am truly a good man and I do love this nation.

Please write. I am looking forward to your personal (truthful and honest) and extensive reply. I am open to a meeting with any of the people mentioned receiving this letter on the condition that my rights will be protected and that I will be honored as a foreign dignitary. No one falsely complains as false statements will only hurt one's general reputation and standing. There were a good number of witnesses that saw what happened to me that day.

I am asking for a meeting with you and a meeting under all of the prevailing circumstances above would most certainly be warranted and would be the proper thing for any upright and responsible U.S. President to do.
