Sometimes, in life, even for disobedient Jews, what life amounts to is in getting what you can get; knowing that God has disowned you and that your lot now rest with Satan.

If you falsely accuse North Korea, you will be bringing about a world war in your effort to weaken China. It is my mission in life, as a paternal Hebrew, to bring about the true worship of God to my people and family, if they are willing to receive him once again.

I am a political negotiator, par excellence, the person who was able to secure Saddam's agreement, when all of the other negotiators in Washington D.C., at that time, could not achieve this feat.

I await your nation's reply and I truly do hope that you will place your trust in God, even in secular matters of state, because I put my trust in God.
