ONE:

Many of you do know of me from my international nation to nation negotiating work and from my many letters to you. Officially by China's history, I am China's current Han-Chinese succession emperor and head of state, therefore, in exile. I am a loyal American and natural born American. My family has lived in the United States of America since 1871, when my grandfather came here as a 10 year old boy with his adult age sister to escape from Manchurian persecution and certain death. We are political exiles from China, known to many in government in Hawaii and Washington D.C.

In 1990-91, I was the unofficial Bush White House negotiator, who secured Iraq's President Saddam Hussein's consent to his withdrawal from Kuwait.

I asked the last four U.S. Presidents for recognition, for U.S. Secret Service protection on an official basis, so that there will be an accounting in the agency and that I would have access to these people, when I need, to advise them as to the many problems faced by me in this nation and with respect to the law, both international (Vienna Convention on Diplomatic Relations 1961), United States, and Hawaii laws. I, also, requested the services of the U.S. Attorney General to protect me from nuisance and frivolous lawsuits and from harassment by press, by US citizens, and by other people and agencies.

I've heard from people that the same condition that existed back in 1871 in China, still exist today for me. This highlights the need for my security protection.

In 1206, China was conquered by foreigners for the very first time. The Chun family with other Chinese warred against the Mongolians and took back China after 162 years. We, China, were conquered by Manchurian people, later, once again, in 1643-44, and so a decision was made by court to continue China's indigenous Han-Chinese succession, rather than to end it. This court installed succession from 1644 is China's official Imperial succession today. Rather than to accept foreign rule over China, once again, court made a very wise decision to continue our family's succession and mandate to rule China.

The Imperial family of China consist of 300 to 600 people in Hawaii, a loose network of about 40,000 related Chinese, in Hawaii and California, and 40 million to 60 million Zhou Dynasty (Chou Dynasty) clan members back in mainland China.

Though it is illegal (based on US and international laws (US Code and the Vienna Convention on Diplomatic Relations), I have been arrested between four to six times. And physically beaten by thugs and police and once left for dead. False reports were generated by police and not one federal agency came to my rescue and assistance. I was, also, falsely arrested and beaten by State of Hawaii Deputy Sheriffs (State police), both, quietly claiming that I am a nutcase and troublemaker disturbing the public peace, which was never the case. I am the innocent victim here and not a law violator. I am a very humble and dignified man and quiet (unknown) international celebrity. Who is protected by the Vienna Convention on Diplomatic Relations from abuse and laws in your nation. Known to many in Congress and in international circles and I do not go around looking for trouble from the police.

So, I am once again requesting quietly for US recognition and for protections as afforded to me by US laws and for protections as rightfully afforded to me under the Vienna Convention on Diplomatic Relations. Is this so hard to understand and does the Obama administration like to play dirty and crooked politics?

I am a very honest and open man. An upright individual and true Christian. I do not go around looking for trouble. I am 61 years old and Emperor and head of state of China as China's emperor in exile.

I am not an opponent to China's communist government. Upon my return I would be a part of China's existing government system as China's Emperor and President of China with Hu Jintao, China's current President, stepping down to become Vice-President.

Whether or not this legal arrangement is approved by China, I am never the less China's emperor in exile and my family succession is legal, legitimate, court installed (1644), and represents the official Han-Chinese succession and royal family of China. Manchurians are known by their four character surname of Ai-sin-chi-lo, where as my family's surname is of only one syllable. We are the descendants of China's Zhou Dynasty.

I am currently poor and unemployed, formerly homeless. I finished four years of college as a business major and history minor.

I am a loyal US citizen and loyal to the laws, high ideals, and worthy principles found here in this nation. I am Chinese so my loyalties also are with China's people and government. I am not an opponent to their system. I am a good man. A righteous man and a true Christian with an eye towards God and an eye towards the goodness of man.

Is there anything that any of you individually or collectively can do for someone like me? I would most certainly appreciate it.

TWO:

I am facing a minor tragedy, that could turn ugly. I and my family have ALWAYS tried to do the right things in this nation and to not go against the laws. We are conformist and not rebels of any kind. We are conservative in our nature and establishment oriented. We do these things in hopes of gaining support and the love and blessing of the American people for our eventual return back home to China. We are paupers, as we, my family, has lost all of our family money and treasury. We supported many families financially (in coming to America and in fleeing from China's cruel and oppressive Manchurian dynasty rule) and saved no money for ourselves. My grandfather had a small store, also, and when people could not afford to pay for merchandise, we allowed them to have food and general merchandise without cost. This is the kind of people we were in this country.

Dignity is important to me. It is important for my return home to China. I am China's holy symbol. China's son of Heaven. So that is an additional incentive to do no wrong, while I am in this nation (United States of America).

1. The police continue to beat me and try to falsely arrest me. They continue to lie on their reports and fabricate evidence, even if none against me exist (a good, honorable, and upright man).

2. There are a few churches, who seem to have it in for me for some unbeknownst reason apart from the truth. I am poor and I have no money. I quietly eat at church soup kitchens without telling the general population there that I am China's emperor. Done for my security and safety. While there, I do speak to the visiting churches and I carefully tell them who I am and of my desire to bring about a Christian mission to China's 1.3 billion people. I ask for their blessing and prayers and ask if their church would be in a position to help a noble Chinese emperor, someone who is down and out on his luck. I tell people of my website, which has my resume, genealogy and documentation so there should be no doubt as to who I am and as to the legitimacy of my person and request. Yet, the church soup kitchen have been blinded to the truth and they do not want me speaking to people. My telling them discretely that I am China's emperor in poverty (my plight) and that I am someone who has a very magnanimous desire and request to see that all people in China have God in their hearts. Matthew 28:19,20. I would rather stay away from such churches, but if I do I will have almost nowhere to get food and eat.

One church wants to have me institutionalized as a crazy person, because, they say, there is no such things as emperors and that I am making such up and that I am crazy.

I visited many churches in Hawaii, in my quest for God. And out of the many churches (40 or more) four have told me that I and my message is not welcomed by their church (refer to my statements above and documented proof of my identity). Most were polite and did not question my identity and credentials.

3. While I do love God and I do believe in our churches, I practice keeping my conscience towards God. If a pastor's sermon was pure or if I agreed with it in principle, I say "amen" to his prayers and sermon. If he, being only human, erred, I would quietly say nothing. At a church soup kitchen there is a very good pastor or priest who knew of this existing situation among the poor and forced all of us to say "Amen" to his prayers and allowed the practice to spread to the Protestant and other congregations here in Hawaii.

4. I am in deep poverty with no income at all. Is there anything that anyone can do to help in the immediate and near future?

PLEASE write. Money, though I hate to ask, in the immediate, is also needed and would most certainly be welcomed by me.
