

To KITV:

I am sending the same set of questions to you for Ed Case, Collen Hanabusa, and Charles Djou. All are running for Neil Abercrombie's seat from Hawaii to U.S. Congress.

1. Officially by China's history, I am China's current Han-Chinese succession emperor living in exile in Hawaii. I am a good man, an upright man, who hopes one day to be China's President and emperor, head of state of China. I am currently an American citizen, a natural born U.S. citizen. I am poor and without any money or friends. I have been beaten by police and by thugs about six to eight times, falsely arrested and assaulted (beaten up and sent to the hospital) and left for dead. As a foreign head of state, I qualify for U.S. Secret Service protection and protections as afforded to me by the Vienna Convention on Diplomatic Relations.

If elected to Congress would you uphold my rights, as I am both a natural born U.S. citizen and foreign head of state, due to my family's lineage and Imperial succession, and would you push for Secret Service protection for me for my temporary stay in your nation? Would you petition Congress and the President on my behalf?

2. In 1990, 1990-91, through a series of letters, postal, e-mail, and fax, as well as telephone calls to important foreign dignitaries, I was able to secure Saddam's agreement to the Bush White House request for Saddam's withdrawal from Kuwait. If President Bush had agreed, our nation would not be at war.

Would you petition Congress, your now knowing the real truth behind this illegal war, and push for an immediate end to an illegal U.S. troop presence in Iraq, Afghanistan, and Pakistan as well as for an immediate end to an illegal and murderous Iraq War?

3. If President Obama was born in Kenya and held Indonesian citizenship, if a vote was taken in Congress to impeach President Obama on these grounds that he is not a U.S. citizen and that his status in our nation is one of being an illegal alien.

To Aiona, Hannemann, Abercrombie,

In my mind, honesty is the greatest asset any man could have. Honest and upright men are respected locally and on the greater world's scene. I am a very small, unimportant, and yet humble man of no or little consequence to anyone of great importance at this time. When I select someone who to vote for, I select people who are honest, upright, and people with integrity. I look and carefully examine the person's background, education and work experience. I look for someone who does not lie about who he is and does not lie about his achievements.

As China's current succession emperor and head of state in exile, a lot hinges on my judgment and on what I do day to day.

I am concerned with our nation's politics and the fact that politicians are not supposed to lie. If our government lies about China and says that China is a danger and threat, people can be coerced into accepting our nation lies and nuking China in order to protect our nation's goodwill (perceived self-interest). Are we right for doing so and is the Iraq War and the killing of two million innocent people ever justified?
