Dear President Obama, Secretary Clinton, and every member of U.S. Congress,

I, sometimes, wonder if Chinese people are welcomed here in the U.S. As all of you do or should know by now, officially by the history of China, I am China's emperor and head of state in exile. The king or emperor of any country is automatically head of state, by history and by definition. In 1990-91, I secured Saddam's agreement that he would withdraw from Kuwait and your intelligence operations had intercepted all of my communications and Saddam's communications to me. In spite of Saddam's willingness to withdraw, your forces didn't allow him to do so with reasonable security for his safety and security. Many people in the press knew this, but didn't testify on account of a lack of evidence from Iraq's government and secrecy on your nation's part involving in high level government matters and communications.

Your war against Iraq and the regime of its legal and legitimate President, in 1990-91, is illegal as your entire government and State Department did truthfully know. Regime change, also, is illegal and nations cannot go ahead and plot, plan, and assassinated the head of state of another sovereign nation. This your nation had done in Iraq to its legal and legitimate President. Illegally going to war, capturing its President, and turning him over to his enemies knowing that he would be killed. This reminds me of King David, who put Uriah in the front lines so he could marry Bathsheba. Somehow, if any nation welded enough power it can skirt any law it wished and violate any law or principle and to even elect an illegal President to preside in its nation's affairs and hold the office of the President illegally. I am putting this question before the entire nation and before the entire world via posting it (this letter) on my website.

When I asked you for Secret Service protection, in an open and official basis, you refused and had not replied to any of my 250 letters sent to you to date. Out of this, 129 letters, including this one, are official correspondence from me, the current succession emperor of China and China's head of state in exile, to you as the President of the United States of America. Many of my letters have been published on my website for the general public to read.

There is good and legitimate need for me to have U.S. Secret Service protection, safe housing, as well as daily maintenance needs. I have sent about 250 plus letters, since your becoming President, and I have not received any reply in return. Would you allow China's emperor or any head of state to go unprotected, unhoused, and without security protection while in your nation? Is this the correct and responsible thing to do? And exactly how should you be treated, if you were in a nation hostile to your presence, by that nation's government?

I am once again asking for U.S. Secret Service protection, money for my daily maintenance as I have none, secure housing, and other needs as my station may deem in your nation.

And lastly, may I remind you, your war with the nation of Iraq is illegal as I had secured Saddam's agreement that he would withdraw. This is something that your nation's government had known, but had ignored. And your government had illegally and criminally turned Saddam over to his enemies knowing that they would have him falsely and wrongfully tried and executed. Is this how your nation cleans up loose ends and is there ever an admission of guilt and wrongdoing by your nation, when your nation discovers that it was wrong? Do you punish and execute wrongdoers who criminally violate laws and murder people (big time) for the sake and in the name of oil? Is this the kind of nation that you lead? Where is your integrity? Do you have none? An apology is due the people of Iraq and full compensation of those wronged is needed. Is this your nation's future course, a nation under God, under the Obama administration?

I hope to lead China in the fashion stated on my website with righteousness and with a loving concern for my people and for humankind. Will I ever receive what I have asked for from your government, before it is too late and I am assassinated or killed?
