Dear President Obama and Secretary Clinton,

Since your coming to office as President, I have written to you over 250 times, formal (130) and informal (120) letters, sending you 130 official letters in my capacity as China's official emperor and head of state in exile. Why have you not answered? I would certainly like to know. Does the Obama administration play dirty politics, favoring those whom the President chooses while ignoring legitimate request and letters?

In 1871, my grandfather came to Hawaii from China. Hawaii became a territory of the United States of America on July 7, 1898 and a state on August 21, 1959 and we (my family) have lived here ever since. So, why is there no reply to an individual who is a good and loyal American?

A courtesy reply directly from you would be nice, especially since I am a foreign head of state, and a lengthy letter is, also, being requested on the issue of my formal recognition. This is required by law in order for me to receive U.S. Secret Service protection for my temporary stay in your country.

I would like the opportunity to meet you, whether in Hawaii or in Washington D.C.

Your personal attention to this letter and reply is, herein, being requested.

A loyal US citizen holding a love for the true god and by birth and genetics a true paternal Hebrew, a descendant of Eber.

Younger cousin of the late Premier Zhou Enlai; younger cousin by marriage-ties to the late Chiang Kai-shek and the late Sun Yat-sen; 8th generation descendant of Chang Cheng-kung (Koxinga); 5th generation descendant of Lum Tse Hsu, Governor-General of Hunan and Hubei provinces, Imperial Commissioner in charge of banning opium; grandnephew of the late Henry P'u Yee Aisin-Gioro, last Emperor of China (Ch'ing Dynasty); great-grandson of Chow P'an Lung; China's current Emperor, head of state of China by virtue of title; and China's symbolic Son of Heaven.

28th generation descendant of Tamucin (Genghis Khan).

90th generation descendant of China's patriarchal emperor Huang Di.

Three generations in my family have loyally worked at Pearl Harbor Naval Shipyard. My maternal grandfather was a shipwright, my father was a radio operator, and I worked there as a military housing carpenter.
