Dear President Obama and Secretary Clinton,

Since your coming to office as President, I have written to you over 250 times, formal (131) and informal (120) letters, sending you 131 official letters in my capacity as China's official emperor and head of state in exile. Why have you not answered? I would certainly like to know. Does the Obama administration play dirty politics, favoring those whom the President chooses while ignoring legitimate request and letters?

In 1871, my grandfather came to Hawaii from China. Hawaii became a territory of the United States of America on July 7, 1898 and a state on August 21, 1959 and we (my family) have lived here ever since. So, why is there no reply to an individual who is a good and loyal American (as well as being China's official Emperor and head of state in exile)?

A courtesy reply directly from you would be nice, especially since I am a foreign head of state, and a lengthy letter is, also, being requested on the issue of my formal recognition. This is required by law in order for me to receive U.S. Secret Service protection for my temporary stay in your country.

Five times, people have repeatedly said that they are going to kill me and you have not done anything about it!

It would, also, be very nice if your government mention my existence to wealthy business men in your nation, so I might be able to receive money/funds to pay for the necessities of life, for other things, as well as to have private security protection in addition to receiving US Secret Service protection from your government. If any foreign head of state was in China, I am sure, I would certainly do the same for them. For their peace of mind and for their security. How much is good foreign relations a concern for you, your nation, and Congress? And to what length would you go to assure any nation's head of state, president, king, or emperor that they would be welcomed and safe in your nation for and during their stay? Then too, would you house a foreign head of state in a homeless shelter with little or no security? How thoughtful!

I would like the opportunity to meet you, whether in Hawaii or in Washington D.C. and have my needs met immediately. Even prior to our first meeting.

My life has been threatened about four times in this country. From memory, at least four to five men have made oral statements saying outright that they would kill me. One was reputed to have been involved in criminal gangs and stripping cars and two of them were staying at the homeless shelter where I, too, live. One man wanted to kill me, merely, for my not giving him a slice of the pizza I bought for the homeless shelter staff. Security protection on an official basis is needed and wanted.

PLEASE reply to this letter, I hope in person, as soon as possible. It is no fun, also too, to live in a homeless shelter and be subjected to disease and personal abuse of many kinds. I would appreciate your nation's kindnesses, thoughtfulness, and Christian love.

From a man, who is legitimately concerned for his welfare, safety, and well-being. Your personal attention to this letter and reply is herein politely requested.

A loyal US citizen holding a love for the true god and by birth and genetics a true paternal Hebrew, a descendant of Eber.

Younger cousin of the late Premier Zhou Enlai; younger cousin by marriage-ties to the late Chiang Kai-shek and the late Sun Yat-sen; 8th generation descendant of Chang Cheng-kung (Koxinga); 5th generation descendant of Lum Tse Hsu, Governor-General of Hunan and Hubei provinces, Imperial Commissioner in charge of banning opium; grandnephew of the late Henry P'u Yee Aisin-Gioro, last Emperor of China (Ch'ing Dynasty); great-grandson of Chow P'an Lung; China's current Emperor, head of state of China by virtue of title; and China's symbolic Son of Heaven.
