In the past, I sent President Obama more than 87 official letters with no reply coming back from him. Officially by China's history and China's Han-Chinese succession, I am Emperor of the nation of China, today, and head of state, thereby, of China in exile, as the king, emir, and/or emperor of any nation automatically becomes that nation's head of state. What I asked President Obama and his predecessors for was official recognition so that I may qualify for Secret Service protection and for rights as given by the Vienna Convention on Diplomatic Relations 1961. To qualify one must be a political figure fleeing from one's home country due to the possibility of eminent death to his and his family's life from prevailing political forces. And such was the case for me, my family, and clan.

This letter is a reminder to President Obama that I am still requesting such and that I am in need of the basic essentials of life. I do not have an income or assets/money to buy goods, food, and medical assistance. And that his help, Office of the President, is and has in the past been requested.

From 1969 to 1974, I worked as a carpenter (carpenter's apprentice). In 1975, my back showed signs of wear and I developed a back condition. This condition has lasted from 1975 to present and I am thereby permanently disabled. I applied for Social Security disability, but was turned down.

In August 2010, approximately, my knees gave way. I am, once again, disabled, doubly disabled. I applied for Social Security supplemental payments and applied for disability from the State of Hawaii. I am legally qualified to receive assistance from both. I was turned down, once again, by our federal government in spite of being permanently disabled.

I am unable to work and unable to hold a full-time position from 1975 to present.

In the past five years, I helped friends clean their homes and yards. If not for friends, I would not be able to survive in this country as I have no money and cannot pay rent or put food on my table. I earned about \$2,500 to \$3,000 per year. I do not and have not help friends (in the past two years) as my situation has gotten worst and I am, also, unable to walk (without the aid of crutches).

During my period of disability, I had no regular job and what little income I made amounted to about \$300 per year. Your government somehow insists on harassing me and having your federally hired bill collector hunt me down to send me continual and disturbing, annoying, and harassing calls requesting payment or they will dun me in some way or other. I am a very upright and sincere individual. I should never be subjected to illegal and harassing treatment. If a person has no money, one just cannot pay any loans or obligations. You as well as the people you hire to hunt me down and illegally harass me should know this. Isn't there some penalty for illegal conduct on the part of government employees? It is very wrong to try to damage a good man's community reputation in an effort to shore up one's illegal presidency. It is very wrong to punish a good man, when he has no money and is trying so hard to be a good citizen for his eventual return to China. You and such people should be punished severely for your illegal and underhanded activities. Good conduct is what every American should uphold. Upon my return to China, I will enforce the same (principles) upon the whole nation of China.

Are illegal and underhanded methods, while maintaining a straight front, part of your modus operandi? What kind of person are you anyway? (1) Born in Kenya and became a citizen of Indonesia. (2) Did not file re-entry papers on your return to this country. (3) Not legally eligible to run for political office in Illinois, but ran in spite the law. (4) Not eligible to be President, but was able to influence (con) our courts and influence (con) many people in high places. This is not the kind of conduct that is becoming of an upright U.S. President!

You need to learn to stop your illegal and underhanded methods and learn to be totally upright. Communicating with people and trying to solve problems is what any good head of state should be doing. Why isn't your press, your nation's news media, on top of stories like what I have published on my site and written to them about?

Is there any way in which an upright U.S. President or other U.S. official could intervene and provide me with medical, financial, housing, and food assistance, while I am a temporary guest in your nation?

An immediate reply is expected. There are many things about you and your presidency that has not been told by our nation's news media. Isn't it time for these things to be made public knowledge?
